1. VET2B Web Platform Information

1. VET2B Web Platform provides services for VET institutions that wish to announce on the VET2B web platform their services/activities that their students can accomplish for SME who request them, within the students practical school activities. The aim of VET2B Web Platform is to enable cooperation and sharing the information about activities being in the scope of VET institutions that could be performed by its learners to serve the need of companies.
2. The Announcements of VET institutions are made available electronically on the Website www.vet2b.eu.

2. Preliminary Provisions

VET2B Web Platform available at www.vet2b.eu is administered by a consortium of partners: Biedriba Belems Macibu Centers – Belem Training Centre (words), Viešoji įstaiga Panevėžio darbo rinkos mokymo centras (Lithuania), ENGIM Piemonte (Italy), Bluebook SRL (Italy), TecMinho (Portugal), and INNEO- Studio twórczego rozwoju (Poland) for the benefit of Users both VET institutions and companies by enabling them to post, view and communicate on VET2B Web Platform.

- The condition for access to the functionality of VET2B Web Platform is to use the device that communicates with the Internet and is equipped with a widely used web browser.
- Having a valid email address.

3. Definitions

- 2. **VET2B Web Platform — online service conducted by the Operator in English, Portuguese, Lithuanian, Latvian, Italian and Polish, that allows to browse and view announcements, available at VET2B.eu;**
- 3. **Announcement - information made available in the VET2B web platform by the VET regarding the offer of a service/activity/product provided for SMEs. Each service/activity/product will be made available by one announcement;**
- 4. **Service — service/product/activity that will be provided by VETs to SMEs that request them and accomplished by the students with the approval of the VET, and is subject of an announcement, under the conditions laid down in the Terms of Use. The service will be related to the course of the students;**
- 5. **Electronic Services — services provided electronically by the Operator to the User via the website consisting of;**
 - a. **Possibility to publish announcements on VET2B Web Platform and to allow free access to view, edit, modify or delete them;**
 - b. **Communication with other users;**
 - c. **Sending email notifications.**

6. User – VET organizations that wish to announce in the VET2B web platform services/activities that their students can accomplish within the students practical school activities and companies who request them. They are represented in the VET2B web platform by a person over 18 years of age and having full legal capacity, which, in the manner provided for in the Terms of Use, has created an account or has activated the announcement;
7. School/VET organization – School or vocational training institution;
8. Account - an account will be assigned to the registered user (VET2B) identified by email address, that allows the user to access the web platform, and publish services/activities/products performed by their students to SMEs that request them;
9. Regulations – These Terms of Use.

4. General Terms and Conditions of Use

1. The announcement is derived from User, which independently sets its content. The content of the announcement must be in accordance with the facts.
2. The inclusion of a announcement should reflect the actual intent of the transaction for which it is classified.
3. Announcements are available for companies thru a inquiry on the website, which sends the User a message to the email address assigned to the Announcement.
4. By agreeing to the issuance of a announcement in the Service, the User agree to the parallel publication of the Announcement elements (including images contained in the announcement) with the Operator's partners. In the case of a publishing a part of the announcement, the contact details will not be disclosed, however it will indicate how to get acquainted with the entire announcement. Publication of announcements with partners is free and serves to obtain as many potential recipients as possible.
5. The Operator protects User data in accordance with the Privacy Policy set out in Appendix 1 to the Terms of Use forming an integral part thereof.
6. Downloading or using any of the available content, within the VET2B Web Platform requires the consent of the Operator of VET2B Web Platform and must not violate the provisions of the Regulations and of the applicable law as well as must not affect the interests of the VET2B.eu. It is forbidden to aggregate and process the data and other information available on the Service VET2B.eu, to be further shared with third parties in the context of the Other online services and offline. It is also forbidden to

use VET2B.eu, including the distinctive elements of the graphic without the consent of the Operator VET2B.eu.

5. Your Rights and obligations

1. The posting of announcement by VET institutions and inquiring of service by companies requires acceptance of the Terms of Use, the User filling in the appropriate form and creating an account.
2. Data collected via inquiry forms for companies are processed according to VET2B Web Portal Privacy Policy.
3. In case of filling in the form referred to above, the email address provided by the User will be used by Operator to promptly send return message to activate the announcement . Email will also contain other information required by law.
4. **After submitting the registration form, the activation of the Account is performed by the Operator. Operator manually validates each new Account before activation. This check is essential to guarantee optimal security for our Users. After the validation, Operator will notify User about successful activation of the Account by email.**
5. The creation of an account and/or the posting of the first announcement is tantamount to entering into a contract between the User and the Operator enabling the provision of Electronic Services under the conditions laid down in the Terms of Use.
6. In the case of legal persons and organizational units, creating an account on their behalf and perform any further actions on the Service may only be a person who shall be empowered to act on behalf of those entities.
7. A VET can only have and use one account on the VET2B Web Platform.
8. VET2B Web Platform does not allow the use of temporary email addresses for Account creation, posting and sending inquiries.
9. Providing of Electronic Services by the Operator is of a perpetual nature, however, the User may at any time delete the account and thus terminate the contract with the Operator while logged in to his account by selecting the appropriate option, by sending your statement in this regard via email to: contact@vet2b.eu.

6. Obligations of the Operator

1. The Operator undertakes to use technical and organizational measures to ensure the protection of the personal data processed, appropriate to the risks and the categories of data protected.
2. The Operator obliges to protect personal data against loss, damage, access to unauthorized persons, removal by unauthorized person, processing and alteration or destruction.

7. Registration and Login

1. In order to register with the website VET2B Web Platform (account registration), you must fill in the signup form with your name and school/**VET** organization details, email address, contact number and password, Accept the Terms of Use of the website VET2B Web Platform and consent to the processing of personal data to the extent necessary for establishing, shaping the content, alteration, termination and proper realization of the Services provided by the Operator electronically.
2. Registration in the Internet Service VET2B Web Platform is free of charge.
3. After registering on the VET2B Web Platform each login is done using the data provided in the registration form (login and password).
4. To delete a User's account from the VET2B website you must send an email with a request to remove your account from the email address currently registered on the VET2B Web Platform to the email address relevant to the country of origin of the school/**VET** organization (see 11 contacts on the) or use the option in your account settings.
5. Logging in to the VET2B Web Platform is done by entering the email address (login) and the password given when registering the school/**VET** organization account in the login form. The data given during the registration of the account can be changed after the account registration ("Account" tab).
6. The User is obliged to keep login and password to his account on the VET2B Web Platform secret. Within the limits of the generally applicable legal provisions of the law responsible for any handling the User's login and password to the account on the VET2B Web Platform, the password is confidential information for the User's exclusive use.

8. Copyright

1. Any content published in The Service is subject to the legal protection-Including: articles, photos and videos used. Copyright is vested in the Service and/or creators.
2. It is forbidden to copy and distribute the website content. It is permitted to link directly to Service articles.
3. When you publish content under the system, you own full right to any content posted by you in the Service – in particular texts, graphics, films and sounds, or multimedia materials have been used under the respective licenses and marked in the proper manner of their origin.
4. You represent that you assume full responsibility for the copyright infringement as a result of the publication of the content on the site.
5. The inclusion of any material in the Service is equivalent to their public availability. You retain the full copyrights to the content that you publish, you make the publication voluntarily and free of charge, your publication may be revoked at any time after sending notification to Operator.

9. Liability Rules

1. The Operator allows Users to post announcements, not interfering in their form and content, subject to the provisions below.
2. The Operator shall not be liable for the improper performance or failure by the parties to contract related to Announcement.
3. The Operator is not responsible for the quality or legality of the services offered, the truthfulness and accuracy of the information provided by the Users, as well as the ability of sellers and buyers to carry out the transaction.
4. The Operator has the right to remove Announcement if it violates the the provisions of the Terms of Use or the laws.
In particular, where it contains content:
 - a. Generally considered offensive;

- b. Of unfair competition;
 - c. Violating good customs, copyright or other intellectual property rights;
 - d. Detrimental a good name or reputation as an Operator or its partners;
 - e. Misleading.
5. The Operator is not responsible for:
- a. Lack of interest in the subject of Announcement;
 - b. Performance of the Users ' obligations under Warranties and conditions regarding the subject matter of the contract;
 - c. Malfunctions due to force majeure, of ICT systems or of equipment from independent Operators,
 - d. User-submitted statements from the other side of transaction,
6. Operator has the right to remove any announcement or block of an account if there is a suspicion that the use of an announcement or account could lead to a threat to the security of other Users within the Service and in the case, in which the announcement adversely affects the Operator's good name or otherwise harms the Operator.
7. The Operator reserves the right to interrupt and disrupt the operation of the website.
